

# NORTHCREST BOAT & TRAILER PARKING RESPONSIBILITIES

NorthCrest Swim Club, (the “Club”) is the owner of a recreational facility located at 839 Hilltop Road, Salt Lake City, Utah 84103, which facility contains a gated parking lot (the “Facilities”).

**Boat & Trailer Parking Information:**

- Members are permitted to park a boat or trailer in the Pool Parking Lot during the off-season which is approximately September 19<sup>th</sup> – May 15<sup>th</sup> on a first come first served basis after agreeing to the terms set forth below and paying the fee.
- Fee \$150.00. Checks payable to Northcrest Swim Club.

**Northcrest Responsibilities:**

- Provide space in the Northcrest Parking Lot.

**Member Responsibilities:**

- Attach contact information near the hitch: Name, Address, Phone Number 1, Phone Number 2
- Park away from building so repairs to the building will be unaffected
- Rake the leaves on or around your boat or trailer prior to the Spring Clean-up day.

The Member agrees to defend, indemnify and hold harmless the Club and the Club's officers, directors, members, employees and volunteers of, from and against any and all liabilities, obligations, losses, damages, penalties, claims, actions, suits, costs, expenses and disbursements (including court costs and reasonable attorneys' fees) arising from or relating to, directly or indirectly, the use of the Facilities by Member or any of Member's guests or invitees pursuant to the provisions of this Agreement, including, but not limited to liabilities, obligations, losses, damages, penalties, claims, actions, suits, costs, expenses, or disbursements arising from or relating to the action, failure to act, or negligence of either the Club or any of the Club's officers, directors, members, employees or volunteers. This release and indemnification agreement releases the above the Club and each of the Club's officers, directors, members, employees and volunteers from any liability for their negligence by the Club or any of its officers, directors, members, employees or volunteers or any other similar or related cause of action of any kind in connection with the Member's use of the Facilities.
  2. The Member shall indemnify the Club for any property damage to the pool or the Facilities relating to its use thereof, and it shall reimburse the Club within ten (10) days following a demand for reimbursement from the Club or any of its agents for any damages to Facilities which in any way directly, or indirectly, relate to the use of the same by Member, in connection with the Member's use thereof.
